





IMPORTANT

To officiate high school flag and/or tackle football in 2026, all officials must register through CIF Office within Arbiter Central Hub.

Once registered (enrolled), CIF will process background checks and issue CIF state testing to complete your registration for the upcoming 2026 season.

The following slides can help you navigate within Arbiter and walk you through the process.

This is a mandatory requirement from CIF. No games will be assigned until your CIF registration is 100% complete. There are absolutely NO exceptions.



CIF Registration Information

Please follow the steps below:

Go to the Eligibility tab in Arbiter.

If you have previously registered with CIF in Arbiter, skip to Step 3.

If you do *not* see anything listed:

Make sure you are signed in to ArbiterSports.

From the Brian Seymour link, click the **Registration** tab and follow the prompts.

Click the **Registration** tab.

Enroll in the sports you officiate at any level. This determines your required tests, insurance coverage, background check, and CIF payment.

After selecting your sports, return to the **Registration** tab, follow the prompts, and complete payment to CIF.

When prompted, select **101837 – OCFOA** as your primary association.

The total fee is **\$30.00 new registration and \$20 if registered last year.**

Within the next few days, CIF will notify you when your tests and additional requirements are ready.

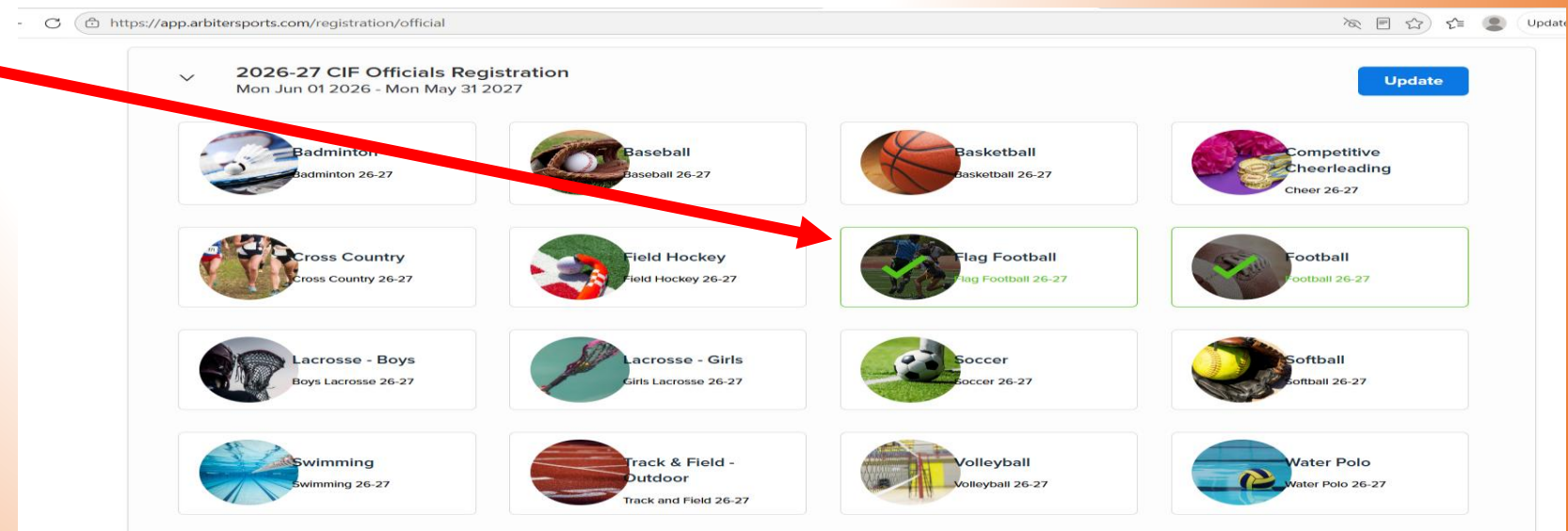
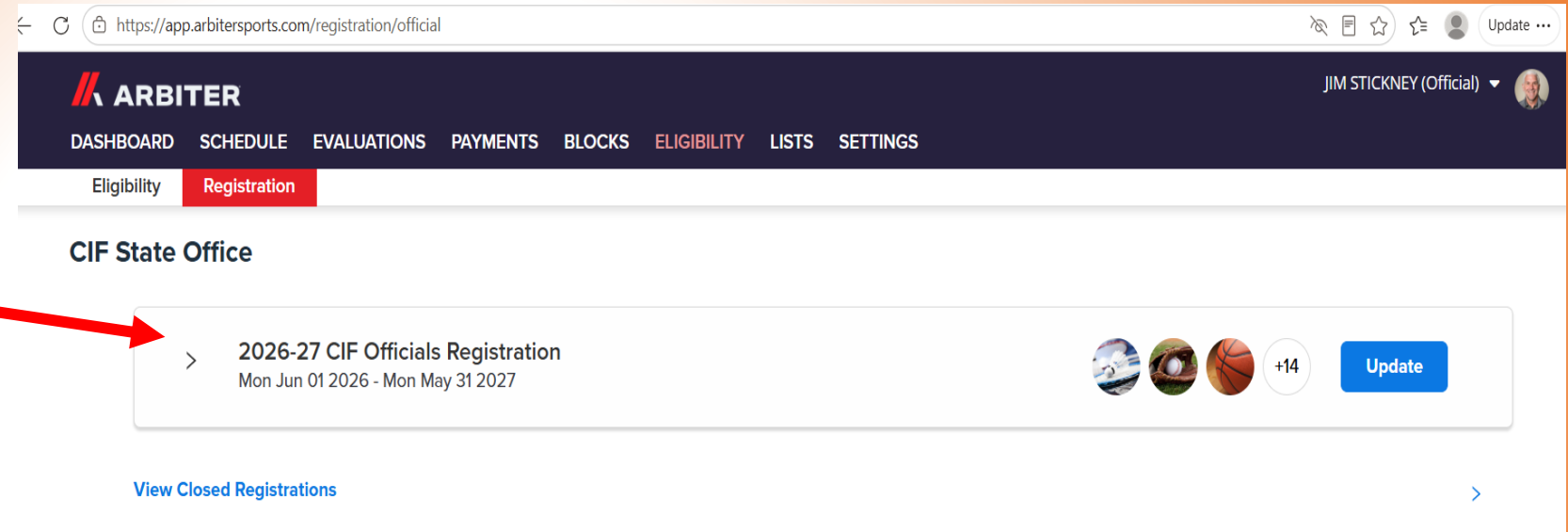
Click "Registration" to select your sports (go to slide 5)

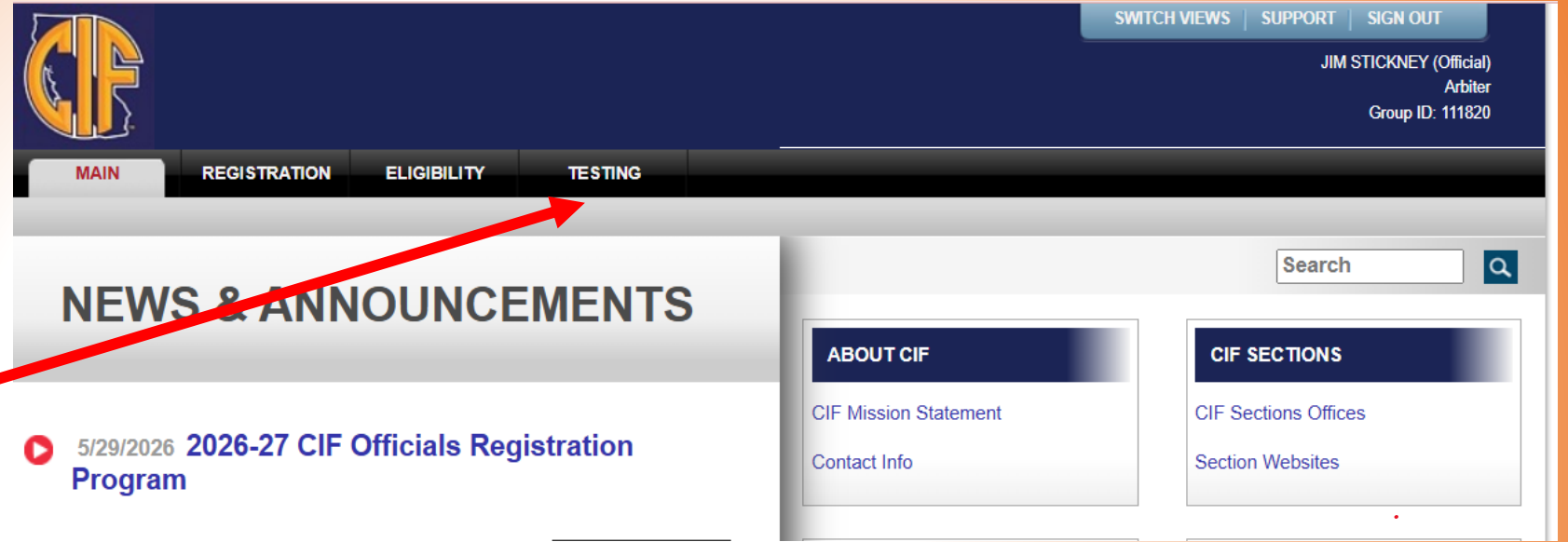
